1. Competition Information

3. SUBMISSION OF ENTRIES

3.1. All participants of the BIMPNT-EAGA Games for Taekwondo event must submit the completed entry forms together with relevant supporting documents to the Organizing Committee by:

3.1.1. 6th September 2018 (Entry by Number); and

3.1.2. 7th November 2018 (Entry by Name).

5. TRAINING

5.1. Training Policies

The Organizing Committee has no objection if participants wish to train outside the Games Village, however, proper attire must be worn and permission must be obtained prior to training.

5.2. Training Venue: Participants are allowed to use the competition venue for training purposes. However, participants may not make any alteration to the competition area such as putting on masking tape, etc.

6. COMPETITION PROCEDURES

6.1. RULES AND REGULATIONS:

- 6.1.1. The rules and regulations for Taekwondo Poomsae in this event will follow the current World Taekwondo (WT) rules and regulations.
- 6.1.2. In the event of a dispute arising from its interpretation, the latest English version of the rules and regulations shall be complied with.
- 6.1.3. Any occurrences not specified in the rules and regulations will be decided as follows:
- 6.1.4. All general actions will be decided based on the BIMPNT EAGA Sports General Rules and regulations.
- 6.1.5. Any technical issues will be decided based on the World Taekwondo (WT) rules which is in force today.
- 6.1.6. Any decision made by the Technical Committee during the competition is final.

6.2. COMPETITION FORMATS

6.2.1. Poomsae events.

The events to be contested are as follows:

Men's Singles

Women's singles

Men's team (3 people)

Women's team (3 persons) and

Mixed Pair (2 persons; one male and one female)

7. TEAM MANAGERS' MEETING

- 7.1. Team managers are required to confirm the list of participant names during Team Managers' meeting.
- 7.2. The Team Managers' meeting will be held on **6 Dec 2018 (Thursday) 2pm.**
- 7.3. The list of confirmed participants during Team Manager Meeting is final.
- 7.4. Managers' Briefing will only be attended by the registered Team Managers and the attendance of the coach is only as an observer.

8. TERMS OF PARTICIPATION

- 8.1. The Participation is subjected to the terms and conditions of BIMPNT EAGA Sports which has been determined by the organizers and Brunei Darussalam Taekwondo Association.

- 8.2. Each contingent is only allowed to send four (4) male and four (4) female participants to participate in the event as set out above.
- 8.3. Participants can participate in more than one event that is contested; however, each contingent is only allowed to send only one entry for the event as set out above.

9. **COMPETITION SYSTEM**

- 9.1. Each participant must comply with the terms and conditions of the competition which has been set by the organizers.
- 9.2. The Poomsae competition will follow the ***cut-off system***.
 - 9.2.1. If a participant or team is competing in an individual or team event of more than 8 people or team, then the first round will be conducted. 8 Participants or Top Team after the initial round will be eligible to enter the finals of the competition.
 - 9.2.2. If a participant or team competes in an individual or team event of less than 8 persons or teams, the Participant or Team in the event will compete directly to the final round of the competition.
 - 9.2.3. Each participant shall report to the competition table THIRTY [30] minutes before the competition begin. If failing to attend after the Fourth call by the technical committee the participant will be deemed as withdrawing from the competition.
- 9.3. The Poomsae Selection will only be determined by the Organizer during the Team Managers' meeting.
- 9.4. Each participant and team shall perform the Poomsae set by the organizer.
- 9.5. The duration of each performance must be between THIRTY (30) to NINETY (90) seconds only. Each participant or team shall present TWO (2) Poomsae. The waiting period between each performance will be between THIRTY (30) to SIXTY (60) seconds only.

10. **ACCUMULATION OF POINTS**

- 10.1. The scores will only be broadcasted after the performance by each participant.
- 10.2. The total score is 10 points, the participant / team with the highest score will be announced as the winner for the event.

10.3. The referee's decision is final. Any objection should be referred to the Competition Supervisory Board.

10.4. Any participant, who fails to comply with the rules of the competition as noted above, shall be removed from competing.

11. PARTICIPANTS' UNIFORM

11.1. Each participant shall only wear Taekwondo Uniforms approved by WT.

11.2. Participants are allowed to wear Poomsae Taekwondo uniform as shown below



11.3. If a Participant(s) in the team event who wishes to wear the Poomsae Taekwondo uniform as mentioned above, all of the members in the group in the pairs or teams event must wear the same Poomsae Taekwondo uniform.

12. REFEREES / JUDGES OF THE COMPETITION.

12.1. The referees and judges will be appointed by the organizer.

13. DISCIPLINE DURING THE COMPETITION.

13.1. All Managers / Coaches and participants must adhere to the spirit of the competition, in addition to respecting and obeying all specified Rules and Regulations.

13.2. All Managers and Coaches must wear appropriate attire.

14. APPEALS AND OBJECTIONS.

14.1. Any appeal or objection shall be made by the Team Manager in writing to the Organizing Committee within a period of not more than 30 minutes after the official decision is announced by submitting a Sum of Money of BND 200.00 (Brunei Dollar: Two Hundred Only).

14.2. If the appeal or objection is successful, the sum of Money will be returned. However, if the appeal or objection fails, the sum of money will be the property of the Organizing Committee.

15. APPEAL JURY

15.1. The Appeal Jury will consist of 3 members of the Delegation and 3 team managers who are not involved with the objection / appeal.

15.2. The Appeal Jury shall convene within two hours upon receiving the appeal or objection.

15.3. The Appeal Jury (if any) shall invite the Team Managers who are involved with the appeal / objection to obtain information from them.

15.4. Any decision(s) announced by the Competition Committee for the appeal / objection is final.

16. DOPING CONTROL

16.1. There will be a random urine test conducted by the Brunei Darussalam Anti-Doping Committee (BDADC).

16.2. Participants found positive for any of the prohibited drugs will result in immediate disqualification. In addition, the same rules as stated by the World Anti-Doping Agency will apply.

17. VICTORY CEREMONY

17.1. Medal winners will go on the victory's podium dressed in their uniform.

17.2. The National anthem will be played for the gold medal winner.

18. MEDIA INTERVIEW

- 18.1. All participating contingent must obtain clearance from the Organizing Committee before proceeding with any interview.
- 18.2. All content of the interview may be subjected to security screening pre-interview and post-interview.
